### Lost-Time Injury Frequency Rate Approach

#### Preamble

This document provides the Barloworld approach to reporting Lost-Time Injury Frequency Rates (LTIFRs) at a group and divisional level.

#### Approach

In light of the diversity of the industries, geographies and legislative jurisdictions in which the group operates, each division has adopted Health and Safety reporting criteria (as detailed in **Annexure A** below) that are most appropriate for their respective operational environments.

The Group LTIFR calculation is a consolidation of divisional inputs being the number of Lost-Time Injuries (LTIs) and total hours worked.

Each division records and reports in line with their respective approach, ensuring comparability and trend analysis. Divisional LTIFRs are disclosed in Barloworld's integrated reporting.

The formula for calculating the LTIFR is consistent across the group and comparable across prior reporting periods:

$$LTIFR = \frac{\text{No. of LTIs} \times 200\,000}{\text{Total hours worked}}$$
